

WEBSITE TERMS OF USE

1. ACCEPTANCE OF THESE TERMS

1.1 These Website Terms of Use (“Terms”) constitute a legally binding agreement between you and Poder De Riqueza Holdings Limited, trading as La Riqueza Global Shop NZ (“we”, “us”, or “our”), governing your access to, browsing of, and use of the La Riqueza Global Shop NZ website located at **www.lariquezaglobal-shop.co.nz** (“Website”).

1.2 By accessing, browsing, or using the Website, you acknowledge that you have read, understood, and agree to be legally bound by these Terms. If you do not agree to these Terms, you must immediately cease accessing and using the Website.

1.3 Where you purchase goods through the Website, such purchase is also subject to our Terms and Conditions of Sale, Shipping, Returns and Refunds Policy, Privacy Policy, Cookie Policy where applicable, and any other policies, notices, or terms published on the Website from time to time. In the event of any inconsistency, the terms specifically governing the relevant transaction or policy shall apply to the extent of that inconsistency.

2. WEBSITE USE

4.4 Nothing in this section limits any rights or remedies you may have under the Consumer Guarantees Act 1993, the Fair Trading Act 1986, or any other applicable New Zealand consumer protection law that cannot lawfully be excluded, restricted, or modified.
